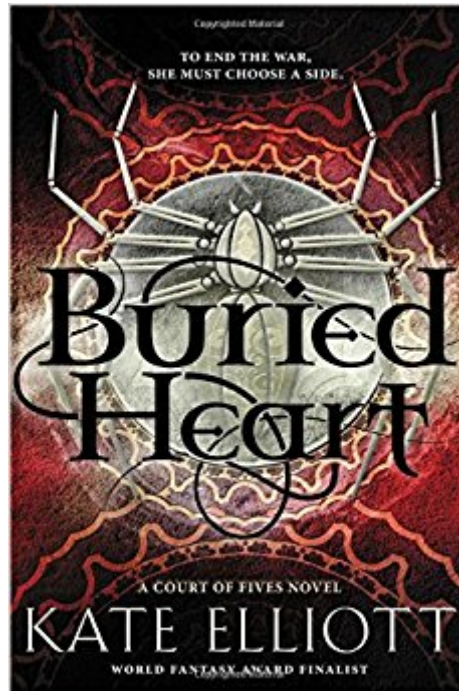

I loved the first book due to the characters, the world building, and the compelling writing. I liked the second book but didn't love it as much as the first as I felt the story was not as fast paced or focused. I liked the series enough to stick with it to this final book. Due to the lapse in time from book 2 to 3, and my voracious reading, as well as the numerous minor characters, I would have appreciated either a beginning synopsis or an appendix with the character names and relationships listed as it was confusing as to who was who outside of the main characters. Overall, an unexpected ending to an enjoyable series. By the way, I am not a "young" adult and think this series is for all fantasy readers.

I really enjoyed spending time with Jes in the detailed world Kate Elliott has built. Jes is strong, strategic, loyal, and Kal is a great love interest. They were separated more than I'd prefer, but for reasons that made sense given their world, situation, and characters. Efea and its people were fascinating and I'd love to read more stories set there.

This apparently concludes her *Court of Fives* trilogy, and it's a decent wrap-up. I won't say much more than that to avoid spoilers; there's a lot of running around and ultimately some battles that seem to pretty well settle the issues that have driven the trilogy; I enjoyed the books, as I have all of Elliott's work I've read.

Such a satisfying end to the trilogy, yet not really predictable. I'm cutting this short because I have to find the next series (of Ms. Elliot's) I'm going to read and get to it. She's my new favorite author!

Buried Heart just keeps turning up the heat as Jessamy continues her complicated relationships with Kalliarkos, her father, her mother, and sisters. The story, situations, and choices will leave you thinking long after you close your book. This is a very satisfying conclusion to the Court of Fives series. My only wishes don't have to do with the book itself: I want to witness a Fives competition in real life (I wouldn't want to be an adversary as I'd break my neck) or commandeer my own spider. Yeah, that spider would take care of rush hour traffic.
