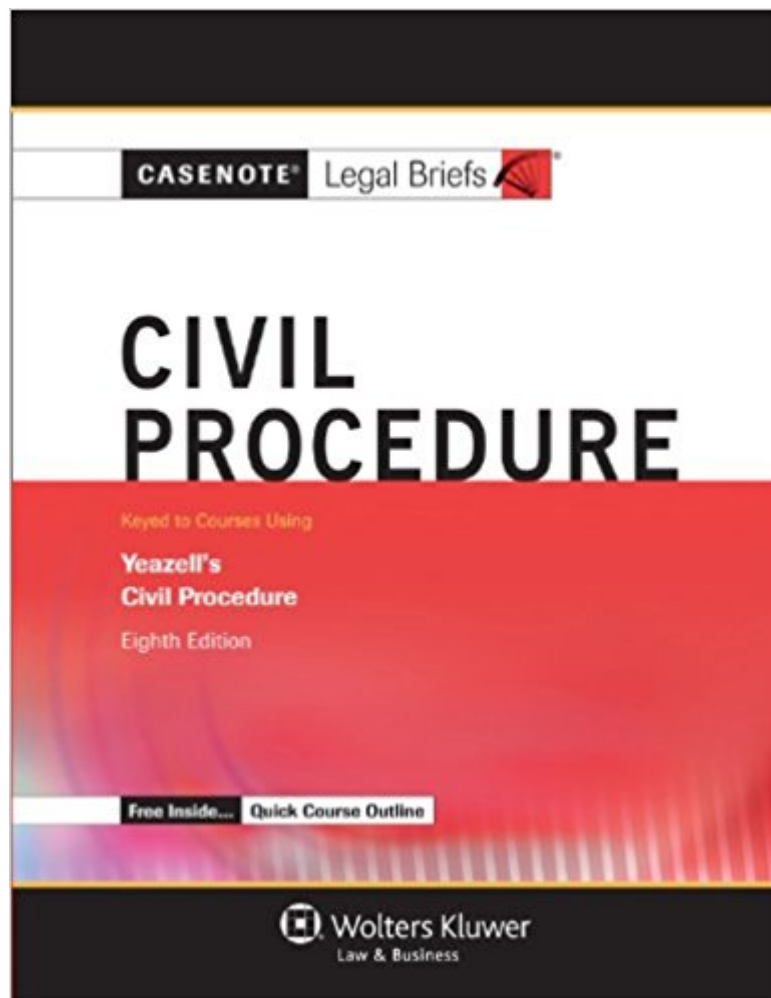

Briefs are little more than a cut and paste from the book, slightly paraphrased. Cases are not explained more plainly to offer a better grasp than the book, rendering it useless for particularly confusing cases. While it might feel comforting to have these in class for cold calls, you'd be just as well off (and often better off) with free briefs easily found online. Invest instead in a good hornbook or E&E (Glannon often recommended for Yeazell textbook) recommended by your professor and/or other students.
